### Chair's Report.

When we started Fylde DFAS almost three years ago, it was great fun as well as a lot of hard work, although everything was on a very small scale. It has been my ambition to consolidate but also grow the Society and expand its influence through networking locally, regionally and nationally. Our numbers have fluctuated slightly but have held up and exceeded predictions. Our finances remained sound as a result and we continued to market ourselves whenever and wherever possible. Strength in numbers has meant an increased presence providing opportunities to influence, to have a mandate to get things done, to be heard, to have an impact and to effectively carry out our commitment to further arts education, culture and heritage in the Fylde. The following report will demonstrate just what has been achieved in 2011/12 as we looked for new ways of interpreting the founding principles of NADFAS, as well as raising our profile and promoting Fylde DFAS as an inclusive and exciting organisation that complements the work of other organisations in the area. For instance we put on the Stanley Warburton exhibition, "An Art Refined" in conjunction with the Fylde Borough Council Working Group, the Friends of the Lytham Art Collection and Booths supermarket.

Advances in technology and communication have opened up new opportunities for the Society and we are adapting fast to the digital age. We need you to come with us on this journey and to take advantage of the local computer courses available and lessons from your children and grandchildren to develop your computer literacy skills. We have noted that an increased number of Members are now on e-mail and we would hope that this will once again grow next year. Once you access our newly designed, bright and fresh website, now easier than ever to use, you will find out not just about the Society's activities but about arts and cultural events in the NW and beyond, as well as photographs of yourselves at events. Also Twitter provides you with a chance to have your say, and be an integral part of our planning and organisation.

The Volunteers Bank expanded this year and a Strawberry Sparkle event was held in July to celebrate and thank contributors for their involvement, enthusiasm and commitment in helping things run smoothly throughout the year.

Finally we have all been able to enjoy the pattern of regular lectures enhanced by Special Interest Days, visits, events and for the first time, a European tour. The subjects have diversified and there has been evidence of passion, enthusiasm and commitment from our visiting speakers, words which also describe that of my Committee. They really are the unsung heroes behind the smooth running of the Society and without them there would be no Fylde DFAS. I would like to use this opportunity to publicly thank them for all their hard work, friendship and creativity. In particular I would like to single out Philip Bailey and Barbara Weston. Philip has manfully fulfilled the role of Vice Chairman from the start but steps down this year, as he will add Heritage Volunteering to his Church Recording portfolio. No, he is not being allowed to ride off into the sunset! Barbara has also been incredibly active and involved; she will leave the Committee to travel more extensively, but will become Society Archivist.

Next year will be my last as Chair of Fylde DFAS and I am looking forward to it being even busier and more successful, which with your help it surely will be. In the meantime please read this report and reflect with pride on all that has been accomplished by you and your Society.

# Programme Secretary's Report: Lectures and Special Interest Days

The Lecture Programme has been planned over a three-year span of time, enabling us to provide a balanced and wide variety of subjects, including both Fine Art lectures and those related to the Decorative Arts, and where appropriate, linked to topical occasions and events. All our lectures are now offered as digital presentations which we feel is essential for the high quality of image required for

The programme for the year opened with a thought-provoking lecture entitled 'Who Says? Can We Trust the Experts on Good and Bad in Art', providing a detailed look at a number of past works of art. By contrast, we were immediately brought up to date with an excellent overview of 'Architecture at the London Olympics 2012'. Michael Howard was welcomed back warmly for our Christmas lecture entitled 'The Journey of the Magi', a familiar subject incorporating the work of different artists over the centuries. Some of the highly complex work on care and conservation of paintings was shown in the lecture 'Angels with Dirty Faces'; and was followed by an unusual lecture 'English Furniture Design Today' relating to various recent commissions seen in grand locations, such as palaces, and cathedrals. Linda Smith was also warmly welcomed back with a popular choice of lecture entitled 'Power, Propaganda and Men in Tights'- a closer look at English Art under the Tudors. Other lectures later in the year include 'Power, Propaganda and Padua in May' A change in the programme enables us to mark the occasion of the Queen's Diamond Jubilee with a lecture entitled 'Windsor Restored'; and a further topical lecture closes the season with an historical view of 'The Original Olympic Games'.

Two Special Interest Days have been arranged this year – last October '5,000 Years of Glass' was held with Andy McConnell, a popular and familiar face on the BBC TV series 'Antiques Roadshow'. This was very well attended and proved to be a most stimulating day. A further Special Interest Day is planned later for April entitled 'From Can-Can to Soup Can: the Story of Modern Art from 1850 to 2000' and is to be held at Lytham Hall.

Please note that a Suggestion Box is always available at the hall entrance and you are warmly invited to offer suggestions of subjects or speakers whom you think may be of interest at our meetings. We always try to incorporate some of your suggestions into our future programmes.

Treasurer's Report.

The accounts presented show a surplus of £560.83 for the year ending 31 December 2011. The General Account showed a surplus of £2729.68 whilst the Good Causes Account showed a deficit of £2168.85 prior to a transfer of £1000.00 between the accounts.

The General Account surplus is due to the membership number being higher than expected and the continued support by our members for the events and Special Interest Days which show a combined surplus of £1338.96.

It was always anticipated, as stated in my Report last year, that there would be a deficit on the Good Causes Account as funds had been raised in previous years to fund expenditure on the highly successful Young Arts Project, 'Mr. Lowry in Lytham St. Annes.' The expenditure on this project during the last financial year was £2659 18

expenditure on this project during the last financial year was £2659.18.

The balance sheet shows the reserves of the Society at £11391.15 on the General Account---which is equivalent to just over a year's expenditure and the Good Causes Account has reserves of £1406.07.

The Committee is proposing to change the year end to 31 July with the current period running 19 months to 31 July 2013. An unaudited interim set of accounts will be produced and circulated for the year to 31 December 2012 to keep you informed of the finances of the Society

The main reasons for the proposal is to ensure that the financial year of the Society is the same as the membership/subscription year and the lecture programme year. Currently they differ --- the subscription year runs from 1 July to 30 June and the lecture programme year from September to July.

Despite the accounts showing a healthy financial position the Committee feels it prudent to propose a modest increase in the annual subscription to £48.00 from 1 July 2012. This will cover the 13 month period to 31 July 2013 where the budget for the period shows a

### Visits and Tours Reports.

### Tour to Krakow.

In May 2011, Fylde DFAS embarked on its first overseas trip to Krakow and over 40 members joined the four-day tour to sample the delights of Poland's beautiful second city. Members had previously been provided with an excellent introductory lecture on the history of the city, courtesy of Douglas Skeggs.

In order to make the journey as easy as possible, several coach pick up points were organised in St Annes, Fairhaven, Lytham and Kirkham, to take people to Liverpool Airport. A further coach carried us from Krakow airport directly to our four star hotel, which was conveniently situated just a few minutes walk from the old town, making it easy for people to get to the major sites on foot.

The first full day included an extensive walking tour of the city, which took in the University and Collegium where Copernicus worked and developed some of his theories on astronomy. We also explored Warwel Hill, a huge Jurassic limestone rock, and home to the Cathedral and Castle. The Cathedral houses a large variety of art, from Gothic to Renaissance to Baroque to Classicist to

The next day included a visit to the world famous Wieliczka Salt Mine, a subterranean museum, housing dozens of statues, carvings and altars carved out of rock salt. We walked down long passages, visiting numerous chambers, including the spectacular cathedral. where even the chandeliers are made from rock.

Day three saw us in a sombre mood as the majority of the group joined the organised trip to the Auschwitz-Birkenhau museums. The sheer scale of the sites, especially Birkanau, was overwhelming. Overall, the tour was harrowing and disturbing but few regretted the experience

This was an escorted tour, with an excellent Tour Manager who was prepared to be flexible and add in extra trips depending on the interests of members. On the first evening he organised an additional optional excursion to a Chopin concert at the Bonerowski Palace, which proved to be a beautiful setting for a musical event. On our third day, a further unscheduled visit was arranged to the Jewish district of Kazimierz. It included a visit to the Remuh Synagogue, which dates from the 16<sup>th</sup> Century and is one of only seven remaining synagogues in Krakow. Our guide also pointed out various locations that were used in the filming of 'Schindler's List'.

Feedback from this tour has been very positive and it quickly became apparent that members would like more of the same. Hence, we have arranged a six day tour to Italy – the Art & Palaces of Bologna, Ravenna, Padova & Parma – for 2012. For those members who can't make Italy, we have also organised a three-day tour to Northumbria in October 2012. It looks like organised tours are set to play an increasingly important part in our future activities.

This very futuristic building is an architectural landmark of natural Jurastone and looks out to the River Mersey and the iconic buildings on the waterfront. On return to the dock area members went to the Maritime Museum which also incorporates the Merseyside Slavery Museum. Meeting up together once again at 3.30p.m. members enjoyed a welcome cup of tea or coffee with

The 'Mr. Lowry in Lytham St. Annes' competition for Year 6 pupils in the Fylde which was launched in October 2010 reached a thrilling and satisfying climax at the end of May 2011 with the submission of well over 200 entries. The standard exceeded our expectations presenting a very difficult task for the judges in deciding the winners. However, in the end, they agreed that the entry from Weeton Primary School should be awarded the First Prize in the class entries with the prize for the best individual submission going to Ella-Grace Gregoire from St. Paul's CE Primary School, Warton.

All the prizes were awarded at a special event held at The Fylde Gallery, Lytham on the evening of Monday, 5 September 2011 when over 100 invited guests attended. The Gallery was then open to the public for the rest of September when about 800 people looked in to admire the 50 or so entries that had been selected for display-----a most thoroughly deserved outcome to a highly rewarding initiative taken by the Society.

Having completed this successful project with local primary schools, which received excellent coverage in The NADFAS Review, we turned our attention once again to the Sixth Form Art Competition sponsored by the Royal British Artists Society and NADFAS. This year most of the local secondary schools with A-level classes participated with the excellent result of two students being chosen to exhibit at the Mall Galleries in London in March 2012. It was a great achievement as we had had a winner last year from a different school and it underlined the impressive young talent that exists in Fylde

schools. Both girls, one from Lytham Technology and Performing Arts College Sixth Form and the other from Blackpool Sixth Form College, are now studying art full time at Higher Education institutions.

This was followed up by "Drawn from Youth 2", an extensive exhibition at the Fylde Gallery showcasing a selection of work shortlisted for the London panel of judges and including drawings, paintings, ceramics, sculpture, fabric design and, in addition, some photography. 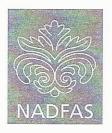
